#### **ACTIVITY**:

- Security Bollards installation continues on the Departures and Arrivals Levels, throughout the Central Terminal Area on the Drop-Off / Pick-Up Curbs
- Departures Level work hours: 10 PM to 4:30 AM\*
- Arrivals Level work hours: 12 AM to 8 AM\*
  - \*Note: Work start and end times may vary when deemed necessary by Airport Operations and project management based on impact to pedestrian and vehicular traffic
- Each section will take approximately 6 consecutive nights to complete
- Multiple crews will be working simultaneously on both levels
- Construction notifications will be sent with information on updated work zones

## IMPACTS: Week of Sunday, April 22 through Saturday, April 28

### **Ground Transportation**

Departures Level:

- Private Parking / Parking Lot Shuttle Zone at Terminal 4 will be temporarily reduced Tuesday, April 17 through Tuesday, April 24 (east third of zone)
- Private Parking / Parking Lot Shuttle Zone at Terminal 4 will be temporarily reduced Wednesday, April 25 through Wednesday, May 2 (middle third of zone)
- Private Parking / Parking Lot Shuttle Zone at Terminal 6 will be temporarily reduced Monday, April 16 through Monday, April 23 (west half of zone)
- Private Parking / Parking Lot Shuttle Zone at Terminal 6 will be temporarily reduced Tuesday, April 24 through Tuesday, May 1 (east half of zone)
- Private Parking / Parking Lot Shuttle Zone Zone at Terminal 7 will be temporarily reduced Thursday, April 26 through Thursday, May 3 (west third of zone)

#### Arrivals Level:

- Shared Ride Van Zone at Terminal 2 will be temporarily reduced Friday, April 27 through Thursday, May 3. The impacted zone will be temporarily relocated to the adjacent west area (west half of zone)
- Taxi Zone at Terminal 2-3 will be temporarily reduced Wednesday, April 18 through Wednesday, April 25 (west third of zone)
- Taxi Zone at Terminal 5 will be temporarily reduced Tuesday, April 24 through Monday, April 30 (east third of zone)

#### **Continuous**

- Construction barricades on the sidewalk will be in place for the duration of the work at each location
- Detours will be in place to guide pedestrians

### **Nightly**

- Portions of the curbside drop-off and pick-up lanes at work zones will be restricted
- Detours will be in place to guide pedestrian and vehicular traffic


